Edderside Lighting No 4 light still missing chairman and clerk have each sent copies of original letters and maps when Allerdale put this light up in the 1990's still has had no reply; Clerk will again ask for reinstatement of this light taken down by NWelectricity it illuminates rough lane at corner of road when lit it shows the corner stopping vehicles from going down lane, Councillor Markley asked to copied into this request, so he could make further enquiries and contact clerk

*Bus along the B5300 there are no subsidy on offer from either Allerdale or CCC Parish Council could still be possibly asking for funding to try to keep bus service (It is possible to increase Precept to support Community Transport) 'Use it or lose it'

*Concerns from the Parish Council to Mr Markley about drainage of road at Dubmill Point, what has been done is not suitable for this road water still stands on road because of the type of drains used not the cuts which let it away
