Newtown Pond:

Brian and Lynda Bailey are co-ordinating the restoration of the pond in Newtown, AONB gave £2000 grant but specified the use of a Conservation Consultant, meeting was held on 17 January to discuss what would be required – clean all brush from back of pond, an island in middle work to be done by March, Aspatria YFC were going to help as part of their 'Community Help' bur only older members to help because of the water element for 'Health and Safety' (will need chainsaws, hand saws and digger) possible contribution from Thos Armstrong Quarries

Clerk informed Reays will discontinue their service 60 on 28 January 2017 recently informed that Ellen Vale will be taking over the route with some changes in route and times, will contact Allerdale for new time tables for the bus shelters
