Risk Assessment:

Annual review of Risk Assessment and Management Report, reviewed by Councillors, agreed all in favour

Planning Application:

FUL/2019/0028 Proposed extension and conversion of current garage. Extension to include a first-floor balcony area – Bank Mill Nursery and Visitors Centre, Beckfoot
Councillors Markley and Cook declared interest on the Planning Committee
After discussion No Objection proposed by MK all in favour

Solfest 2019:

RA and SD attended meeting at Wheyrigg Hall Hotel an invitation from the Solfest Committee
a. Stated had concerns about access to the proposed new site, roads not suitable

Cllr OM stated that the existing licence is in a different name than in previous years, they will need to apply for a new licence

The proposed new site will require Police presence for the one-way system they talked about

It was proposed the Clerk send letters to Allerdale Borough Council Charles Holmes and Andrew Seekins and the CCC Event Management Team about the Parish Councils concerns

It was pointed out the B5301 could be closed for major repairs with monies held back March 2019, after the B5300 is reopened, proposed RA all in favour

Mawbray Speed Limit:

From the meeting held 10 April 2019 a resident of Mawbray, asked if a 20mph speed limit could be applied for in Mawbray, Parish Council to wait for the official 30mph limit signs to go up after many years of applying for this limit as yet to be granted by CCC, will look into applying for a 20mph speed limit and speed bumps proposed MK all in favour

Allonby to Silloth Cycleway:

JM has been in correspondence with Joe Broomfield officer in charge of proposed plan
Since application discussed 07.03.19 the Car Parks at Beckfoot are to be kept open, still concerned about the original grant application, and lack of knowledge within the Planning Application, Cllr Markley suggested a Parish Councillor attend the Planning Meeting and raise these concerns. JM willing to attend

Dubmill Diversion:

Tourists do not know about diversion signs and there poor directional signs at Play Area and other roads, clerk to contact Highways to check signage

Refuse Bins:

Only parts of the Parish have purple bags, every household has been delivered a new paper bin, old ones to be used for recycling, still not all households on the recycling collection list. Clerk to contact Charles Holmes Allerdale Borough Council
