Matters from the minutes:

The Lowther – shares have gone on sale for the public buy out. Planning for change of use goes before Allerdale Planning Dept meeting on 02.09.20

Grass cutting at B5300 junction at Brookside Farm has ceased at request of the landowner, Parish Council have cut his land for visibility and to keep the area tidy

Wild flower meadow – looks untidy – there is to be a concerted effort to clear area of ragwort, docks and creeping thistles, next month a full mow will take place with grass being removed. Mrs Knoery looking into funding and an action plan AONB supplied contact for ‘Get Cumbria Buzzing’

Chairman’s Announcements:

CALC reorganising Cumbria – are we going to have more responsibilities – who will fund – send reply next meeting

Highways -MK has been contacted by concerned residents of Mawbray about the number of heavy wagons through the village, have already contacted Amber Sykes CCC Highways, she contacted bridge department and police, this was not a one-off incident, residents have also contacted Police. Clerk to contact AS again to request more weight restriction signs

Lighting footways – check number on Allerdale list correct and working correct

Parish Plan will be scheduled for restart March 2021 and make it an ongoing item – something every meeting

Refuse Bins – seems a lot have been damaged and broken and have not been replaced when requested. Clerk to contact department

Sign Post painting – clerk to look into cost – Carl Melville CCC Engineer said his dept could supply paint and insurance if local residents would be interested in the work
