**Minutes of a meeting of Holme St Cuthbert Parish Council held on:** Wednesday 13 October 2021 in Holme St Cuthbert Parish Hall at 7.30pm

## Apologies:

Pre-application to new sand quarry for gravel and minerals Goodyhills Quarry C2019 5 miles north of Aspatria Goodyhills, Mawbray CA15 6QX

- 1. Applicant will need screening on all sides of proposed site bunds and trees will be need to done as soon as possible to allow any screening to be covered on vegetation with trees and shrubs to mature this to prevents noise and blowing sand from any workings
- 2. Upgrade of roads to be done as soon as possible to help with any work that is to done pre quarrying
- 3. Working hours 7.00am 6.00pm Monday to Friday 7.00am 1.00pm Saturday this is in line with other sites in the area
- 4. There needs to be a full environmental impact survey, the proposed is above the Tarn which is fed from local springs and field drains with clean water, supporting many and varied aquatic and marginal wildlife
- 5. Impact on the local tourist trade, visitors and the local caravan park (North Lakes Caravan Park) which is situated around the Tarn, this is an expanding business and the Quarry will have a detrimental impact to the area
- 6. The cross over period from closing off High House Quarry could be two years until Goodyhills Quarry is fully running with infrastructure in place, concern about the movement of sand along the B5301 pinch points Overby and Aikshaw more wagons on the road, at present many Harrison's wagons go through Abbeytown whereas Armstrong's o towards Silloth using the Overby entrance onto the B5301 or Aspatria using Aikshaw junction onto B5301 missing the narrow point at Aikshaw Cottages
- 7. Major concerns about noise and blowing sand even is suitable bunds and screening are in place

This application was sent to Mr R Armstrong chairman of the Parish Council, will send a brief reply asking for an extension to time, so that RA can contact local residents about the pre-application proposed MK all in favour
