**Natural England:**

Update NW Coastal Access May 2023 – now 117 miles of the King Charles III England Coastal Path open in NW From Allonby to Green Road around Walney Island from Tarleton to Liverpool

**Speed Awareness Wheelie Bin Stickers:**

Council have agreed to purchase wheelie bin stickers for Mawbray, count number of houses in village and contact company with order

**B5300:**

Number of signs on triangle to be kept monitored are causing an obstruction to road users turning onto B5300, Also concern about the number of cars parking on the green at school times 'Keep your Children Safe' put notice in Church magazine, parents could park at village hall or Mabray Banks Car Park. Keep green clear for better visibility
