DB most concerned about the main climbing frame structure, some of the Committee want to keep main structure manly for sentimental reasons, but others think it should be removed, the Play Area Committee have been offered a play structure no longer required by Holme St Cuthbert School, which is much newer and needs new height requirements, the original structure has been up over twenty years
