# MINUTES OF THE MEETING

**Minutes of a meeting of Holme St Cuthbert Parish Council held on:** Wednesday 18 September 2024 in Culterham Hall, Mawbray at 7.30pm

(LS) Thanked the Solfest Team for attending the meeting

Weather – worst weather all week leading up to festival during build – managing safety on site Wednesday night storms – 8.00am call – Thursday morning cancelled, Thursday evening performances and opening cancelled to make safe, causing traffic problems, long distance travellers were allowed on site to camp Friday morning localised flooding had the knock-on effect to queuing along B5301towards Westnewton, making it difficult for locals and businesses to operate

The churning of field gates, putting down track matting and wood chips at entrances and exits caused stoppages in traffic flow

Looking forward – better traffic management, getting vehicles of the roads, issue of car parking tickets and wristbands – process people quicker – looking to what could be done better

Local residents concern they could not contact Management Committee – telephone number not on the letter which was sent out, DS said also difficult to find on the website and info

Traffic using Goodyhills, Edderside and Holme St Cuthbert Road, also causing problems on the Edderside road, issued with tickets showing advised routes to and from site

Adrian and Sam to meet with Parish Councillors to visit problem areas

(RA) pointed out that four delivery wagons blocked cross roads at Tarns when turning to access and leaving the site, this should not have happened at all al large vehicles were sent at intervals

(AB) said this was a 'Perfect Storm' could not fully have been planned for, but tested their management of site. Thanked all crews for their safety work, and locals for help and donations of tents etc when the weather was the worst, could have been managed better learning for the future

Environmental Health visited the site twice to check safety etc before being signed off

Solfest Committee, DS and CA left the meeting at 8.30pm

Clerk visited Mrs Williamson, if she had any replies, at present nothing, but agreed to keep Parish Council informed
